

Minutes of Kaber Village Hall Working Group Meeting

1. Attendees

3. Matters Arising - None

4. Legal:

Feedback on SL meeting with the Charity Commission regarding the changes to the constitution.

Sarah provided a report from her meeting and clarified the relationships and differences between Trustees, Committee Members and "Friends". This led the meeting to understand that because of our constitution (the changing of which would be problematic) the following was the situation:

- 1. The "Committee of Management" aka "The Committee" shall be Trustees.
- 2. We cannot use "Committee" or "Management Team" as such names would (by implication) mean that members would automatically become Trustees (because of point 1)

3. We should increase the number of Trustees from the current 3 to 4 as the CC always require a minimum of 3, and to have a fourth trustee would minimise the risk if a current Trustee needed to step down.

The meeting decided the additional Trustee would be Damon Green – who has agreed – once the document is finalised.

This led to a discussion about organisation arrangement going forward that would reflect the requirements of our constitution and our desired operational practice. We would form a "Working Group" which would undertake the day to day running of the Hall.

This Working Group would be comprised of the current Trustees, and additional Individuals appointed by the Trustees. These Individuals will be appointed for a period determined by the Trustees, but such appointments would terminate at the next AGM. Such individuals would then be eligible for reappointment by the Trustees if required. All members of the Working Group would have full voting rights on matters discussed by the Working Group.

We have had no formal applicants to become "Friends of Kaber Village Hall". So there seems no point in retaining this concept. It is recognised that community members do (and will hopefully continue) help with the running of the Hall and events, raising funds etc. without needing to have formal titles.
